**This Waiver and Indemnity Agreement ("Agreement") is made and entered into by and between:**

**WHEREAS**, FilAm Arts offers a program known as the FilAm Teen Council ("Teen Council") that provides opportunities for Filipino American youth to participate in cultural activities and leadership development.

**WHEREAS**, Participant desires to participate in the Teen Council.

**NOW, THEREFORE, in consideration of the foregoing premises and the mutual covenants contained herein, the parties agree as follows:**

**1. Participation**

Participant agrees to abide by all rules, regulations, and guidelines established by FilAm Arts for the Teen Council program.

**2. Waiver of Liability**

Participant acknowledges that participation in the Teen Council program may involve inherent risks, including but not limited to physical injury, illness, or property damage.

**Participant, on behalf of themselves and their heirs, assigns, and successors, hereby waives, releases, and discharges FilAm Arts, its officers, directors, employees, volunteers, agents, and representatives (collectively, the "Released Parties") from any and all liability, claims, demands, losses, or damages arising out of or in any way connected with Participant's participation in the Teen Council program.**

### 3. Indemnity

Participant agrees to indemnify and hold harmless the Released Parties from any and all claims, losses, or expenses (including attorneys' fees) arising out of or in any way connected with Participant's participation in the Teen Council program, including but not limited to any claims of negligence on the part of any Released Party.

### 4. Medical Authorization

In the event of a medical emergency, Participant authorizes FilAm Arts to seek necessary medical attention for Participant. Participant (and, if applicable, Participant's parent or legal guardian) agrees to be responsible for all costs associated with such medical care.

### 5. Medical Insurance

Participant (and, if applicable, Participant's parent or legal guardian) warrants that Participant has health insurance coverage in full force and effect.

### 6. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of California.

### 7. Entire Agreement

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior or contemporaneous communications, representations, or agreements, whether oral or written.

### 8. Severability

If any provision of this Agreement is held to be invalid or unenforceable, such provision shall be struck and the remaining provisions shall remain in full force and effect.
